In determining which grantees will be monitored, the Department uses a risk-based approach to rate grantees, programs and functions, including assessing the Department's exposure to fraud, waste and mismanagement. This process not only assists the Department in determining which grantees to monitor, but also identifies which programs and functions will be reviewed. As a result of our analysis of your program(s), the following areas and activities were identified for review:

CDBG - Public Improvements HOPWA - Evergreen Health Services Financial Management

SUMMARY OF RESULTS AND CONCLUSIONS

Areas reviewed may result in the identification of findings, concerns or exemplary practices. CDBG - Public Improvements

Summary: No findings or concerns were noted.

The City of Buffalo uses CDBG funds for a variety of activities to help community neighborhoods, as described in their Annual Action Plan. Some of those activities include making improvements to streets and sidewalks. These projects are administered by the City through a subrecipient agreement with the Buffalo Urban Renewal Agency.

The scope of the monitoring review focused on ascertaining the City's compliance with the eligibility and national objective requirements of the CDBG program, utilizing the above referenced Exhibit 3-1 and Exhibit 3-2. The following two public improvement projects were randomly selected as the file sample for review during the monitoring:

IDIS activity 9739, Street Improvement – Hamlin Park IDIS activity 9667, Sidewalk Replacement – Black Rock

As part of the monitoring process, the file records and documentation for these projects were examined and site visits were made to both projects.

The CDBG program requires the City to use CDBG funds only for eligible activities. The City has systems and procedures in place to make sure projects are determined to be eligible prior to funding them. Both projects were determined to be eligible. Therefore, the City is compliant with this requirement of the CDBG program.

The City is also required to meet a national objective, one of which is to benefit 51% or more persons who are low- and moderate-income (LMI). The City's file records contained information showing that LMI persons had benefitted from both public improvement projects.

In summary based on the above, the City has personnel and systems in place for making eligibility determinations that result in eligible activities being funded and properly classified, and the City is documenting and serving low- and moderate-income persons as required. As a result, there are no findings or concerns noted with respect to this area of the monitoring review.

HOPWA - Evergreen Health Services

The City of Buffalo provides housing assistance for person with AIDS through its sponsor agency, Evergreen Health Services. The monitoring review examined the City's compliance with program requirements, utilizing the above referenced Exhibit 10-1 and Exhibit 10-2. The following two activities were randomly selected as the file sample for review during the monitoring:

IDIS activity 9458, Evergreen Health Services – TBRA IDIS activity 9459, Evergreen Health Services – FBHSA

As part of the monitoring process, the file records and documentation for these projects were examined, interviews were conducted with personnel from the City of Buffalo and Evergreen Health Services, and site visits were made.

Overall, the City and Evergreen Health Services have systems and procedures in place to manage the HOPWA program and are maintaining adequate records to demonstrate compliance with program requirements. The monitoring review confirmed that clients met applicable income guidelines, had appropriate medical documentation, and received the appropriate level of rental assistance. As a result, there are no findings or concerns noted with respect to this area of the monitoring review.

Financial Management

The financial management systems and procedures used by the City were examined during the monitoring review, utilizing the above referenced Exhibit 34-1. As part of this process, the review focused on the City's budget and accounting records, disbursements, internal controls, and audit reports.

The City's Single Audit Report is current for the period ending June 30, 2018. The report contains one (1) Financial Statement Finding and no current year Federal Award Findings. The Financial Statement Finding 2018-001, Solid Waste and Recycling Fund Deficit, does not have a direct impact upon the management of U.S. Department of Housing and Urban Development (HUD) funds. However, it is the City's responsibility to ensure that this finding is corrected according to the auditor's recommendation.

The City's financial management systems provide adequate control and accountability of CDBG and HOPWA funds. The City's accounting methods have been established in accordance with HUD requirements and meet generally accepted practices.

The City's system of internal controls provides adequate separation of duties and responsibilities so that grant funds are properly safeguarded. The City has written policies and procedures in place for setting up activities, reviewing invoices for payment, and approving expenditures.

As a result, there are no findings or concerns noted with respect to this area of the monitoring review.
