## SLOW STREETS 2023 APPLICATION

### APPLICATIONS ARE DUE AUGUST 1, 2022

Use this application form to request traffic calming, like permanent speed humps, in your neighborhood.

If you or a neighbor applied to the Slow Streets program previously, your neighborhood zone will be shown on the applicant map at [www.buffalony.gov/SlowStreets](http://www.buffalony.gov/SlowStreets). In this case, your application process will carry-forward and you do NOT need to apply again.

After submission, your application will be reviewed by DPW. If it meets the criteria for traffic calming through the program and there is Slow Streets funding available for your neighborhood zone, DPW will contact your point person and begin conducting public outreach prior to traffic calming measures being installed.

- Your neighborhood zone will be evaluated from a traffic perspective. The boundaries may be adjusted based on factors like traffic patterns, size, and the proximity to other zones.
- If your neighborhood zone is deemed suitable for traffic calming and there is Slow Streets funding available for your neighborhood zone, DPW will contact your point person and begin conducting public outreach prior to traffic calming measures being installed.
